**The Customs and Excise (General) (Amendment)
Regulations, 2018**

IN EXERCISE of the powers contained in section 198 of the Customs and Excise Act, the following Regulations are made:

1. These Regulations may be cited as the Customs and Excise (General) (Amendment) Regulations, 2018, and shall be read as one with the Customs and Excise (General) Regulations, 2000, in these Regulations referred to as the principal Regulations.

2. Regulation 87A is amended by the deletion of sub-regulations (1) and (2) and the substitution therefor of the following:

87A. (1) A person with a disability who is registered with the Zambia Agency for Persons with Disabilities as defined under the Persons with Disabilities Act, 2012, shall be granted remission of duty payable in respect of one modified motor vehicle upon certification by the Ministry responsible for persons with disabilities.

(2) Any rebate, remission approved pursuant to this regulation shall be granted—

- (a) only once in a period of five years;
- (b) on condition that the modified motor vehicle concerned is not sold, or otherwise disposed of, except with the prior consent of the Commissioner-General and on payment of duty, if any at the rate leviable at the date of that sale or disposal; and
- (c) on other conditions that the Commissioner-General may determine.

3. Regulation 127 is amended by the—
- (a) insertion of the following new sub-regulation immediately after sub-regulation 2:
- (3) The Commissioner-General may require that risky goods transiting through Zambia, as determined by the Commissioner-General from time to time, are conveyed by containerised transport or by a vehicle delivery service; and
- (b) re-numbering of sub-regulations 3 and 4 as sub-regulations 4 and 5.
